Transportation Title VI

Mr. Ian Cole briefed the board on the Title VI of the Civil Rights Act of 1964 as amended prohibits discrimination on the basis of Race, Color, National Origin, Sex, Age (Over 40), Religion, Sexual Orientation, Gender Identity, Veteran Status, Disability, Limited English Proficiency, or Low Income, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which the Recipient receives Federal financial assistance (42 U.S.C. 2000d). Mr. Cole informed the board this has to be updated every year and that he had included a copy of the link in the packet, had also included it as an attachment in meeting email, and if you would like a hard copy he would be glad to provide after meeting is adjourned. Mr. Cole asked for board to approve. Mr. Teddy Coffey made motion to approve, Mr. Allan Chapman offered a second, motion carried.
