# Audit Update

Mr. Skip Campbell, Campbell, Myers and Rutledge, CPA, thanked the LCADD staff for being so cooperative. Mr. Campbell presented a draft of the FY 19 Audit to the Executive Committee advising them of the Independent Auditors Report, the Management Discussion and Analysis, the Schedule of Operations and reported there were no questioned costs or findings making this a very good audit. A copy of the draft is on file in the Finance Department of the LCADD and a copy of the draft audit is at the Auditor of Public Accounts (APA) for review. Mr. Tony Meeks, Director of Finance, presented the Financial Report; a copy is attached and made a part of these minutes. After discussion Ms. Sharon Payne made a motion to approve the

Executive Director McGaha presented a change in Policy and Procedure. The first is in regards to hiring Interns.

To be eligible for LCADD internship position, the individual must have completed his or her sophomore year at an accredited college or university and must have declared his or her major prior to the start of the internship.

The second is in regards to Section V: Compensation Plan. The changes are attached and made a part of these minutes.

After reviewing and discussion Judge Mike Anderson made a motion to accept the changes to the LCADD Policy and Procedures. Judge John Phelps, Jr.

Deputy Executive Director Nick Hazel explained that each of the job descriptions is listed as non-exempt for overtime.
