# Lake Cumberland Area Development District Executive Committee May 18, 2022

### Call to Order

Ms. Sharon Payne, Chairperson, called the meeting to order at 8:28 a.m. central time at the Lake Cumberland ADD office in Russell Springs.

# Approval of Executive Committee Minutes

Judge Randy Dial asked if there were any questions/comments regarding the executive minutes of the previous meeting (April 20, 2022). There being none Mr. Hershell Key made a motion to accept the minutes as enailed. Judge Barry Smith seconded and motion carried.

## P&F Committee Report

Judge Randy Dial stated the P&F Committee met prior to the Executive Committee meeting and the following was brought before the committee.

Mr. Tony Meeks, Director of Finance, presented a monthly statement as of April 30, 2022. After discussion Judge John Phelps, Jr. made a motion to accept the financial report as presented and Judge Mike Anderson offered second. Motion carried.

#### Personnel

Mr. Devore, Deputy Director and HR Director, reported that Brian McGaha had been interviewed for the Pulaski County Senior Citizens Center Director position and hired. He reported that Fara Miniard had been interviewed for the Economic Development Specialist position. He requested approval to offer her the position. Judge Phelps made a motion to recommend hiring Ms. Miniard. Judge Smith seconded the motion. Motion carried.

Mr. Devore reported that Houchens Insurance Group met with him, Mr. Wright and Mr. Meeks and shared that the Anthem health insurance through KACO would be increasing 10%. Mr. DeVore also stated that KLC had recommended a 7% cost of living adjustment and that in-house leadership had reviewed the program budgets and it appeared that a 7% adjustment is sustainable. Mr. Devore stated that the proposed adjustment included all jurrent staff and the Executive Director. Judge Dial asked for a motion to recommend approval of the 7% cost of living adjustment and keeping the existing insurance, with the agency covering the 10% increase. Mr. Hardwick made a motion. Judge Phelps seconded. Motion carried.
