

**Lake Cumberland ADD Regional Transportation Committee**  
**Thursday, March 5<sup>th</sup>, 2026 @ 12:00 Central Time**  
**Meeting Minutes DRAFT**

Chairman Eddie Thomas, Mayor of the City of Russell Springs, called the meeting to order at 12:02 p.m. in-person as well as via Zoom conference with 25 persons attending. Chairman Thomas welcomed everyone then asked for a motion to approve the minutes from the December 2025 meeting. Motion to approve the minutes was made by Judge Executive of McCreary County Jimmie Greene. Seconded by Mayor of Burnside Robert Lawson. All in Favor. Motion Carried.

Mr. Young also discussed projects in the construction phase, as well as, project completion dates. 
